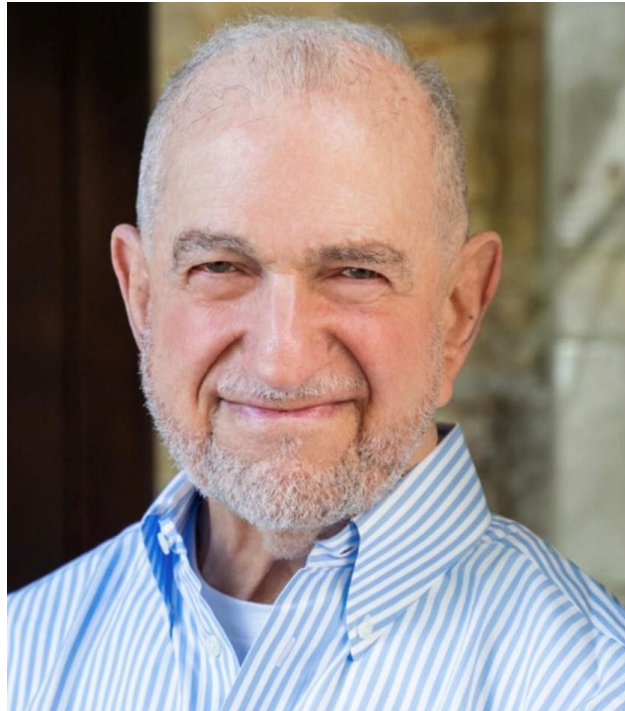

Richard Levin is an independent international and domestic arbitrator specializing in complex disputes, with a special focus on competition, antitrust, and IP cases. International arbitration has always been a substantial part of Richard's practice throughout his career during his time with international law firms. With over 35 years of experience in cross cultural disputes, first as counsel and then as arbitrator, Richard became a full time arbitrator in 2018.

Richard started his career after serving as a law clerk to the Hon. John C Godbold (United States Court of Appeals, Fifth Circuit) later joining Sullivan & Cromwell in New York. It was here that he worked on complex international cases, mainly competition related.

Richard came back home to Dallas, Texas to work at Akin Gump Strauss Hauer & Feld joining as an Associate and later becoming a Partner in their litigation department for almost four decades. While at Akin Gump he been involved in cases at the cutting edge of the law.

Richard was counsel in one of the first disputes under Chapter 11 of the NAFTA Treaty, and one of the first competition related international arbitrations. His career has included experience as counsel representing companies in nationwide and global criminal antitrust/competition matters, as well as follow-on treble damage claims.

Richard has been appointed as sole arbitrator and as a panel of three in numerous arbitrations under a range of arbitral and ad-hoc rules involving most legal systems globally. He is a Fellow of the Chartered Institute of Arbitrators, and due to his truly international presence globally he was named to and made a member of CIArb's Presidential Panel of Arbitrators and later selected to be a Chartered Arbitrator in 2018, the highest designation by the Chartered Institute (C Arb). He is also a panel member of most international institutions around the world and has an exceptional reputation as counsel and arbitrator. He is a member of Newman's Row in London to assist his practice.

While Richard exclusively concentrated on his arbitrator and mediator practice since 2018, he has continued to maintain his pro bono practice representing children with learning disabilities with their legal issues during their school careers.

**International Arbitration**

Richard's practice has involved all phases of international and domestic arbitration. He has been instructed or appointed in numerous arbitrations under ICC, UNCITRAL, AAA/ICDR, and ICSID rules, both as counsel and as member of three-person arbitration tribunals (AAA/ICDR, CPR, and ICC), as well as sole arbitrator. Richard has been appointed or counsel in over 150 arbitrations of which he has made approximately 100 awards.

- Member of three person CPR tribunal in complex IP royalty dispute in pharma industry
- Sole arbitrator in complex consumer dispute alleging unconscionability and other claims against internet and telecommunications company
